



Company Overview

- LCC Projects Ltd. is a Gujarat-based multidisciplinary EPC company primarily focused on irrigation and water infrastructure, with over two decades of experience. Its capabilities include dams, barrages, weirs, hydraulic structures, canals, underground/pressurised pipeline networks, lift irrigation, water-supply schemes, WTPs, STPs and sewerage networks. It has a presence across 12 states.
- The company has an in-house design and engineering team and uses technologies such as SCADA, IoT, GIS and WaterGEMS for technically complex projects. It has also diversified into metro rail and mining (MDO) and is pursuing opportunities in wastewater treatment, sewerage, solar/renewable energy, river linking and desalination.
- As of March 31, 2026, LCC had an unexecuted order book of ₹7,953.18 crore, equivalent to 2.21x FY26 turnover, across 103 projects. The three largest projects were Sondwa Lift Micro Irrigation – ₹1,534.95 crore, Sidhi Bansagar Multi-Village Scheme – ₹1,525.14 crore, and Gandhi Sagar 1 Multi-Village Scheme – ₹1,153.90 crore, providing strong medium-term revenue visibility.
- The business remains overwhelmingly EPC-driven, with ₹3,594.57 crore or 99.84% of FY26 revenue generated from EPC and only 0.16% from O&M. LCC is also building adjacent capabilities through its precast concrete manufacturing unit, renewable-energy capabilities through LCC Engineering, and 14 joint ventures, supporting its expansion into a broader range of infrastructure projects.

Sector Outlook

- India’s irrigation systems market is expected to grow at a 10.9% CAGR during 2023-2028, driven by agricultural modernisation and improved water-use efficiency. Government initiatives such as PMKSY have supported growth, with central government assistance exceeding ₹64,407 crore.
- Government infrastructure spending remains strong, with ₹12.2 lakh crore of public capex allocated in FY2026-27. The NIP investment target has increased from ₹111 trillion to ₹160 trillion, supporting sustained opportunities for EPC and water-infrastructure companies.

Company Outlook

- LCC Projects Limited has achieved strong financial momentum, with revenue from operations growing at a CAGR of 21.50% to reach ₹3,600.25 crore in FY2026, while PAT grew at an impressive CAGR of 53.23% to ₹286.44 crore. This growth was supported by robust operating and return ratios, including an EBITDA margin of 14.44% (up from 9.90% in FY2024), RoCE of 27.13%, RoNW of 32.24%, a healthy debt service coverage ratio of 2.51, and an improving leverage profile, with the total debt-to-equity ratio declining to 0.97x from 1.23x in FY2025.
- LCC Projects is coming up with an IPO of ₹427.14 crore, comprising a fresh issue of ₹258 crore and an OFS of ₹169.14 crore. The company will not receive any proceeds from the OFS portion. Of the fresh issue proceeds, ₹14.69 crore will be utilised towards purchase of equipment, while ₹180 crore will be used for prepayment/repayment of certain outstanding borrowings; the balance will be utilised for general corporate purposes.
- At the upper price band of ₹146, LCC Projects is valued at a post-issue P/E of 14.76x and EV/EBITDA of 9.61x, which appears reasonable considering its strong order book, healthy earnings growth, established execution capabilities and favourable long-term prospects in irrigation and water infrastructure. While government dependence and project execution risks remain key concerns, the overall risk-reward profile is favourable. We recommend a “Subscribe” rating for the issue.

Key Risks

- LCC Projects is exposed to government policy, budgetary and procedural risks, as 89.34% of FY2026 revenue came from central and state government contracts, while its top 10 customers contributed 72.30% of revenue.
